# **Privacy Policy**

This Privacy Policy ("Policy") applies to www.hernandogrc.com, and Hernando Golf & Racquet Club ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include www.hernandogrc.com. The Company's website is a golf and racquet club informational site. By using the Company website, you consent to the data practices described in this statement.

### **Collection of your Personal Information**

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:

- -First and last name

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. ### **Sharing Information with Third Parties**

### **Tracking User Behavior**
